



TERMS AND CONDITIONS

Golf Cart Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. PROMOTION DESCRIPTION

The NORTH STAR COMMUNITY CREDIT UNION GOLF CART GIVEAWAY (“Golf Cart Giveaway”) begins on July 1, 2018 at 12:01 a.m. and ends on May 30, 2019 at 11:59 p.m. (the “Promotion Period”).

The sponsor of this Giveaway is North Star Community Credit Union (“Sponsor”). By participating in the Giveaway, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Giveaway. Entrants should look solely to Sponsor with any questions, comments or problems related to the Giveaway. Sponsor may be reached by email at promo@northstarccu.com during the Promotion Period.

2. ELIGIBILITY

Open to legal residents of the United States who are 18 or older (the “Entrant”) and are within North Star Community Credit Union Field of Membership Requirements. Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (the “Promotion Entities”), are ineligible to enter the Giveaway or win a prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. “Household Members” shall mean those people who share the same residence at least three months a year. “Immediate Family Members” shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. Grand Prize: One (1) winner will receive One (1) Golf Cart (approximate retail value or “ARV”: \$5,999.99)

Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prize represents Sponsor’s good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items.

Winner agrees to exhibit Sponsor’s logo on the Prize up to one year after the Promotion Period ends.

This Giveaway is open to legal residents of the United States and Prize will only be awarded and/or delivered to an address within North Dakota. 4. HOW TO ENTER

Enter the Giveaway during the Promotion Period by visiting any branch of North Star Community Credit Union and speaking with a member service representative. Registrants will need to open a new account type or begin a new service if he or she has an already existing account. Registrant will receive an Entry for each new account type opened.

Registrant’s account(s) must be open and in good standing when the Promotion Period ends. Dealer indirect lending and leasing loans will not count as an Entry. Business accounts will not count as an Entry.

Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All Entries must be posted by the end of the Promotion Period in order to participate.

5. WINNER SELECTION

The Winner of the Giveaway will be selected in a random drawing from among all eligible Entries received throughout the Promotion Period. The random drawing will be conducted on Saturday, June 1, 2019 by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible Entries received.

6. WINNER NOTIFICATION

Winner will be notified by email or phone number at the email address or phone number provided in the Entry approximately 1 week after the random drawing. Potential Winner must

accept a prize by email or phone as directed by Sponsor within 2 weeks of notification. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive email account(s), disconnected phone lines, technical difficulties associated therewith, or Winner's failure to adequately monitor any communication medium.

Any winner notification not responded to or returned as undeliverable may result in prize forfeiture. The potential prize winner may be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively "the Prize Claim Documents").
